## **GENERAL COURSE DESCRIPTION:**

Today, the environment has become one of the most pressing issues on the political agenda. Politicians are forced by many constituents to take a stand on environmental issues, risking electoral consequences if they do not. Is that fair? Do the arguments and positions of environmentalists need to be questioned? This course surveys the association between environmentalism and politics, seeking to inform students of the debates about the environment and to examine several of the associated political themes as well as the main analytical, legal, and ethical approaches used in creating environmental policy.

- identify an overview of key environmental agents, including political organizations, institutions, and processes through discussions and lectures;
- summarize and explain environmental legislation through discussions and lectures;
- place particular environmental case studies in both the domestic and international context through discussions, lectures, and class presentations;
- develop interpersonal/teamwork and oral communication skills through class presentation; and
- use critical and analytical thinking to assess course content and themes through exams.

## **COURSE TOPICS:**

- Environmental political culture: attitudes, beliefs, goals, and values
- Environmental themes, theories, and ideology
- Environmental social movements; interest groups, including Indigenous; and political parties
- Environmental law, regulation, and ethics
- Environmentalism in international foreign policy and development
- Potential solutions to the environmental crisis

 Case studies on environmental policymaking, drinking water, nuclear waste, mining, oil/gas, and/or global warming
