GENERAL PROGRAM DESCRIPTION:

This comprehensive 43-week Hairstylist Foundation (pre-apprenticeship) program is designed to prepare students for entry-level positions in the hairstylist industry. The program provides students with skills that are needed as a first year hairstylist apprentice, including those related to salon hygiene practices, effective use and maintenance of tools and equipment, hair cutting, styling, and colouring, chemical waving and relaxing, as well as communication skills and basic business management skills. The program is delivered through regular lectures, demonstrations and practical skills training in a fully functioning salon. Students participate in a three-week practicum in a registered salon and may complete their work-based training hours in the College of the Rockies Hair Salon or in an accredited hair salon of their choice under a Red Seal qualified stylist. Students will have opportunities to experience and participate in local indigenous community events as related to the Hairstylist program. Safety and hygienic practices are emphasized, reinforced and practiced throughout the program.

Credentials Granted: Upon successful completion of the 43-week Hairstylist Foundation program, students receive:

- Level 1 Technical Training credit from the Industry Training Authority for the Hairstylist Apprenticeship program
 - Certificate of Completion from the Industry Training Authority
 - College of the Rockies Certificate
 - Credit for 1290 Work-based training hours from the Industry Training Authority

Pass Requirements

In order to pass this program, students are required to

- achieve a minimum overall 70% final percentage score**
- pass all Workplace Health and Safety courses within the program

This program has a Standard Written Exam (SLE) that is administered by the Industry Training Authority on the last day of the program. In order to be eligible to write the SLE, students must have a final in-school percentage score of 70 % or higher.

The final percentage score for determining credit for the Hairstylist Foundation program is calculated by ITA Direct Access and is determined as follow:

In-school Percentage Score

Combined theory and practical subject competency multiplied by 80%

Standard Written Exam Percentage Score

The exam score is multiplied by 20%

SAFETY:

WorkSafeBC regulations apply to all trades programs. Students are expected to follow all safe work practices and have high regard for the safety of others as well as of themselves.
